Blackstone will allocate the Fund's assets among investment subadvisers with experience managing alternative investment strategies and among investment funds. It may also manage a portion of the Fund's assets directly.








Gross strategy attribution^{1,5}

Performance commentary

The investment objective of Blackstone Alternative Multi-Strategy Fund (the “Fund”) is to seek capital appreciation by allocating assets among a variety of investment sub-advisers with experience managing non-traditional or “alternative” investment strategies. During the month of January, the Fund was able to protect capital and provide a return of +0.70% despite a challenging backdrop. The Fund’s low beta to equity markets, broadly diversified exposures and low volatility helped boost overall returns in a largely down tape and also provided outperformance versus the broader hedge fund universe (HFRX Global Hedge Fund Index returned -0.20%).

As the new year began, investors held new hopes of a stronger U.S. economy. But while U.S. GDP growth has been outpacing that of other industrial countries, there are still some developing headwinds. Positive data showing that cheaper gasoline and the largest employment surge in the U.S. since 1999 are boosting consumer confidence was partially offset by the reality that business investment may be simultaneously abating. In fact, some companies are facing declining global sales due to slowing growth overseas, plunging oil prices and a rising dollar.

While excessive attention centered on the deflation of footballs in the NFL, the real story of the month concerned deflation in the Eurozone. Though stimulus was widely anticipated, the European Central Bank (ECB) moved to stem deflation in Eurozone economies by announcing a €1.1 trillion bond purchase plan that was much larger than expected. Prolonged weakness in those economies prompted the bank to implement a similar type of quantitative easing as that carried out by the U.S. Federal Reserve until last October. Blackstone and the underlying sub-advisers of the Fund strive to be nimble in volatile markets in order to make strategic portfolio shifts to take advantage of these types of market dynamics and themes.

Equities:

Following positive performance in 2014, global equities were off to a choppy start to 2015. As market volatility continued to take center stage in January, the Fund had a strong month of alpha generation. As equity markets fell (S&P 500 and MSCI World indices declined by -3.00% and -1.54% respectively), the Fund not only protected capital but also produced a positive net monthly return. While not all Equity managers had a positive month, overall Equity strategies were the largest positive contributors to the Fund’s performance in January, as idiosyncratic exposures stood their ground amidst general weakness in the asset class. The hedged nature of Equity Long/Short strategies also helped the Equity component of the portfolio produce alpha. From a top-down perspective, the portfolio benefited largely from its overweighting to Healthcare, which outperformed other sectors during the month. Our equity sub-advisers’ expertise in bottom-up security selection also helped them separate the winners from the losers in that sector. Additional contributions to our Equity performance came from investments in Information Technology, Real Estate and Asset Management.

Credit:

As fixed income markets experienced gains (Barclays Agg Bond Index returned +2.10%), the Fund’s Credit strategies ended the month mostly positive as the long-awaited ECB announcement took most of the focus mid-month. It was a positive surprise to the market and gave further fuel to tightening credit spreads that were already narrow. Several Opportunistic Trading and MBS/ABS strategies profited from positive carry and spread tightening during the month. Some ABS exposure, in particular, experienced gains driven by robust performance in the underlying collateral. Upward moves in the High Yield market, along with a combination of lower U.S. Treasury yields and retail inflows, also added to gains amongst some of our Credit sub-advisers. Weakness in this part of the portfolio was driven by losses on securities backed by reperforming loans.

Multi-Asset/Quantitative:

Multi-Asset/Quantitative strategies had mixed performance during the month. The Swiss National Bank (SNB)’s surprise unpegging of the Swiss franc caused the currency to appreciate, which cost some quantitative managers. However, some of our Multi-Asset strategies benefited from short euro positions as currency continued its slide from last month. Additionally, Emerging Markets exposures faced increasing headwinds in the form of rising volatility and reduced liquidity in fixed income assets.
